Rick said that this AGM is the first face-to-face gathering – almost to the day – since the AGM in March 2020. The impact on Probus has been immense with all of our groups having to cease during lock down. Then eventually some were able to start, albeit in a socially distanced way, for example the cycling groups. Then as restrictions eased even more, other groups started to meet, observing social distancing rules. The Executive Committee continued to meet every month – initially on Zoom then face-to-face - trying our best to find creative ways to communicate with members and keep the Club going. Daphne, Lyn and Jean did a wonderful job with their inspired Corona Times newsletter which, was very much appreciated and widely read. In an effort to start to get members back together, even with numbers restricted, we decided to hold social events four weeks in a row in October 2020 in an effort to give members an opportunity to gather together in Probus fellowship. Over the year 2020, we inducted 10 new members. Rick also mentioned how important it is for members to step up to take Committee and other positions when they become vacant, and the difficulty there was in filling the Committee positions for 2021. A number of members are continuing on in their positions has a result.
